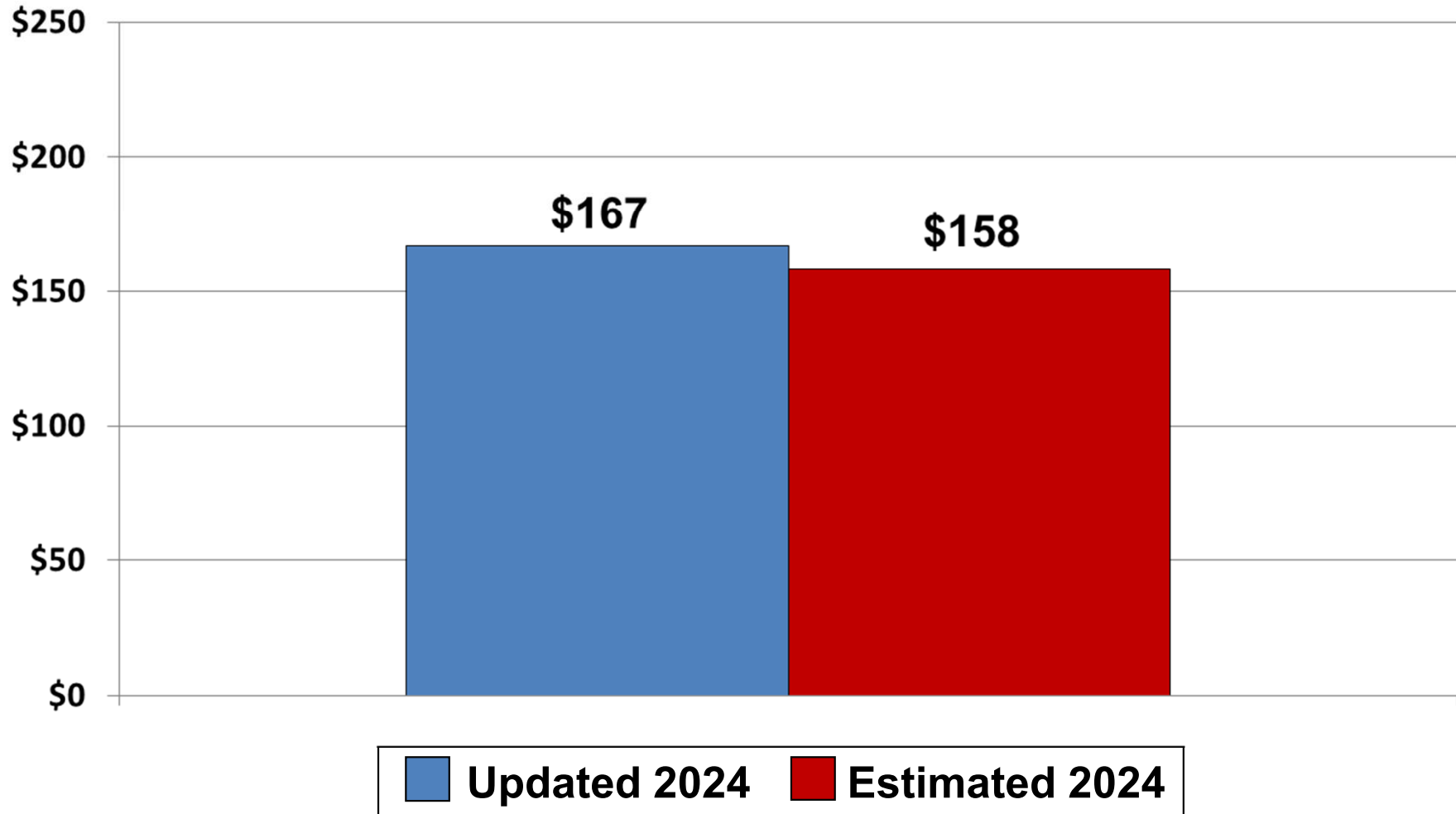

2024 Total Plant in Service Costs (Millions of Dollars)



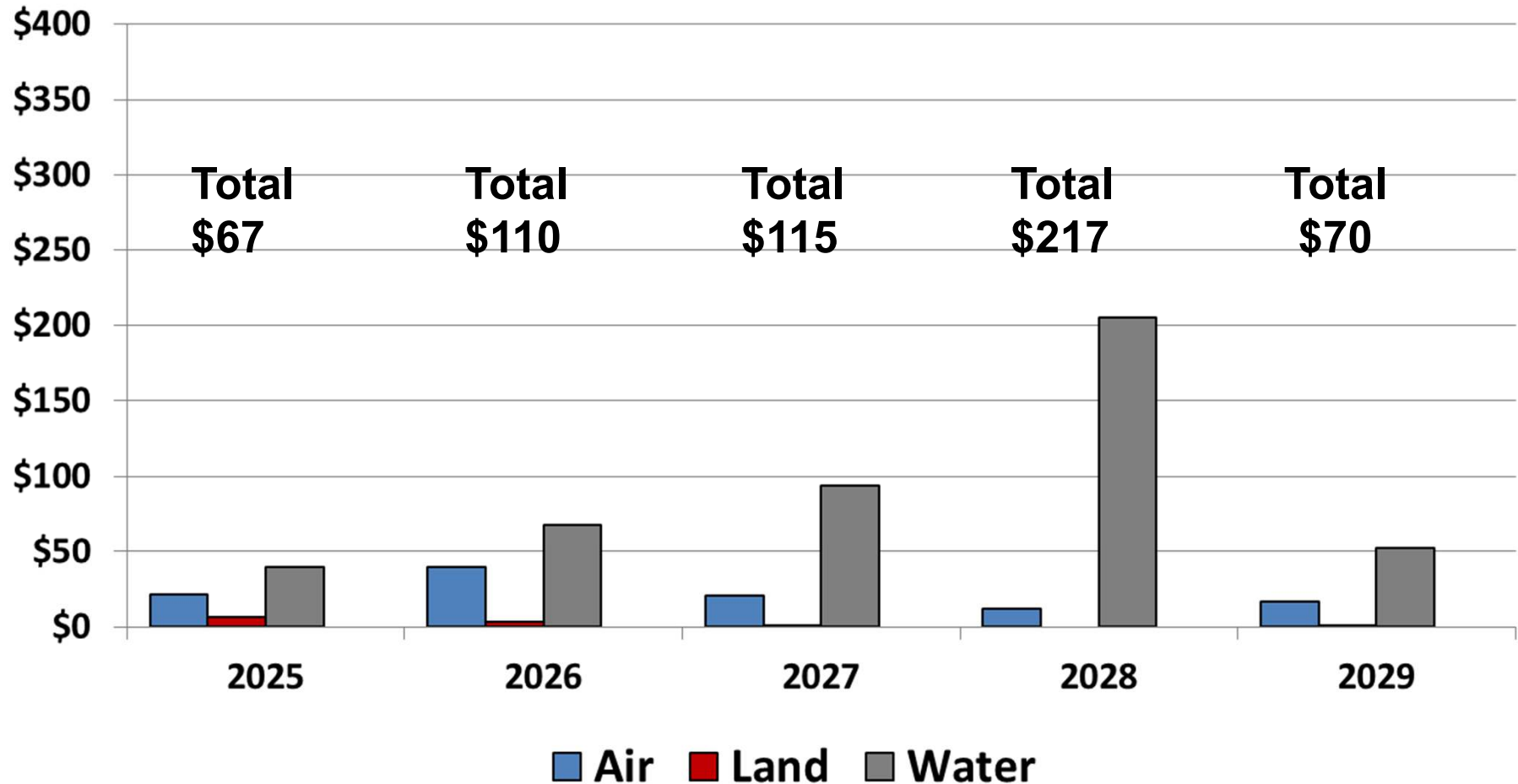

2024 Operation & Maintenance Expenses (Millions of Dollars)



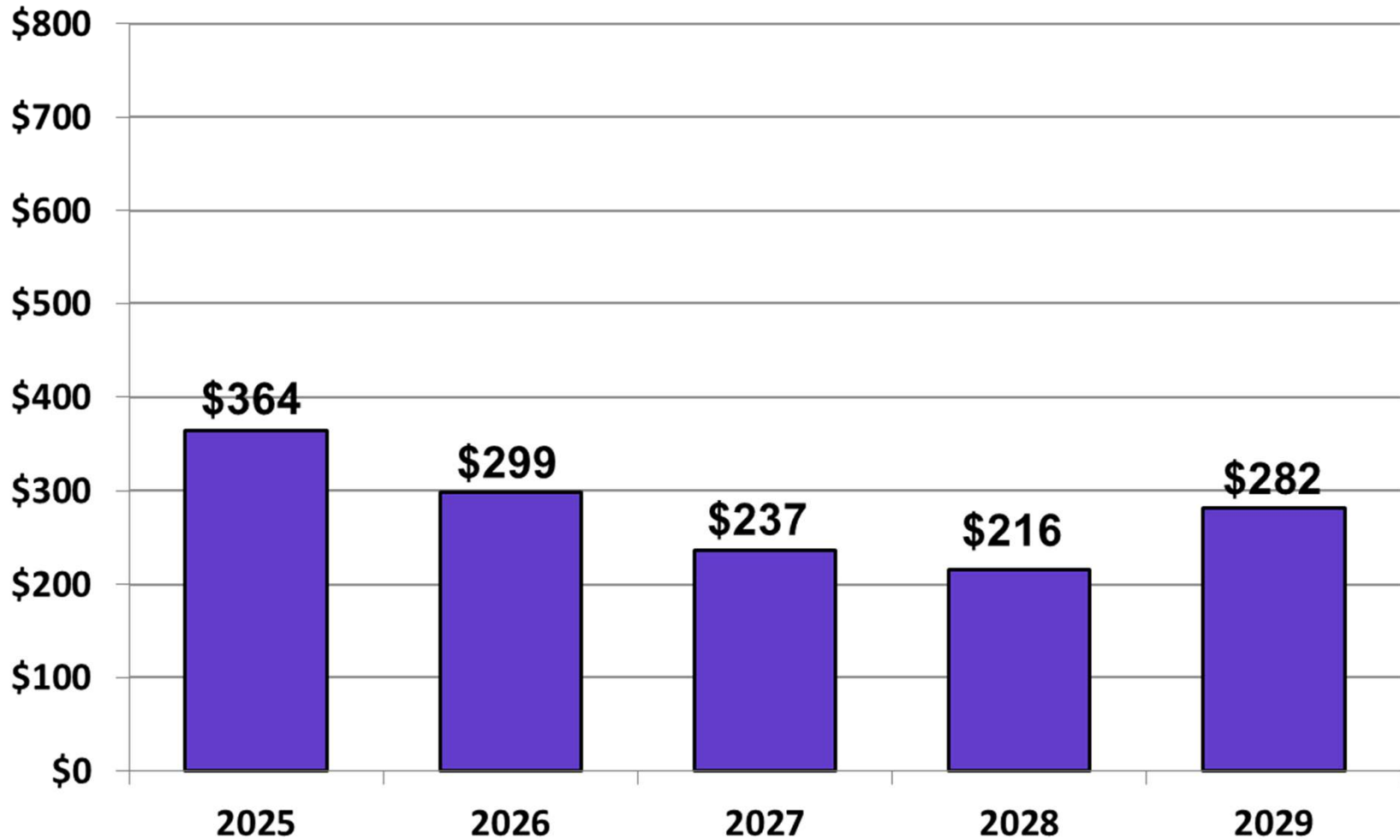

Estimated 2025 – 2029 Capital Expenditures (Millions of Dollars)



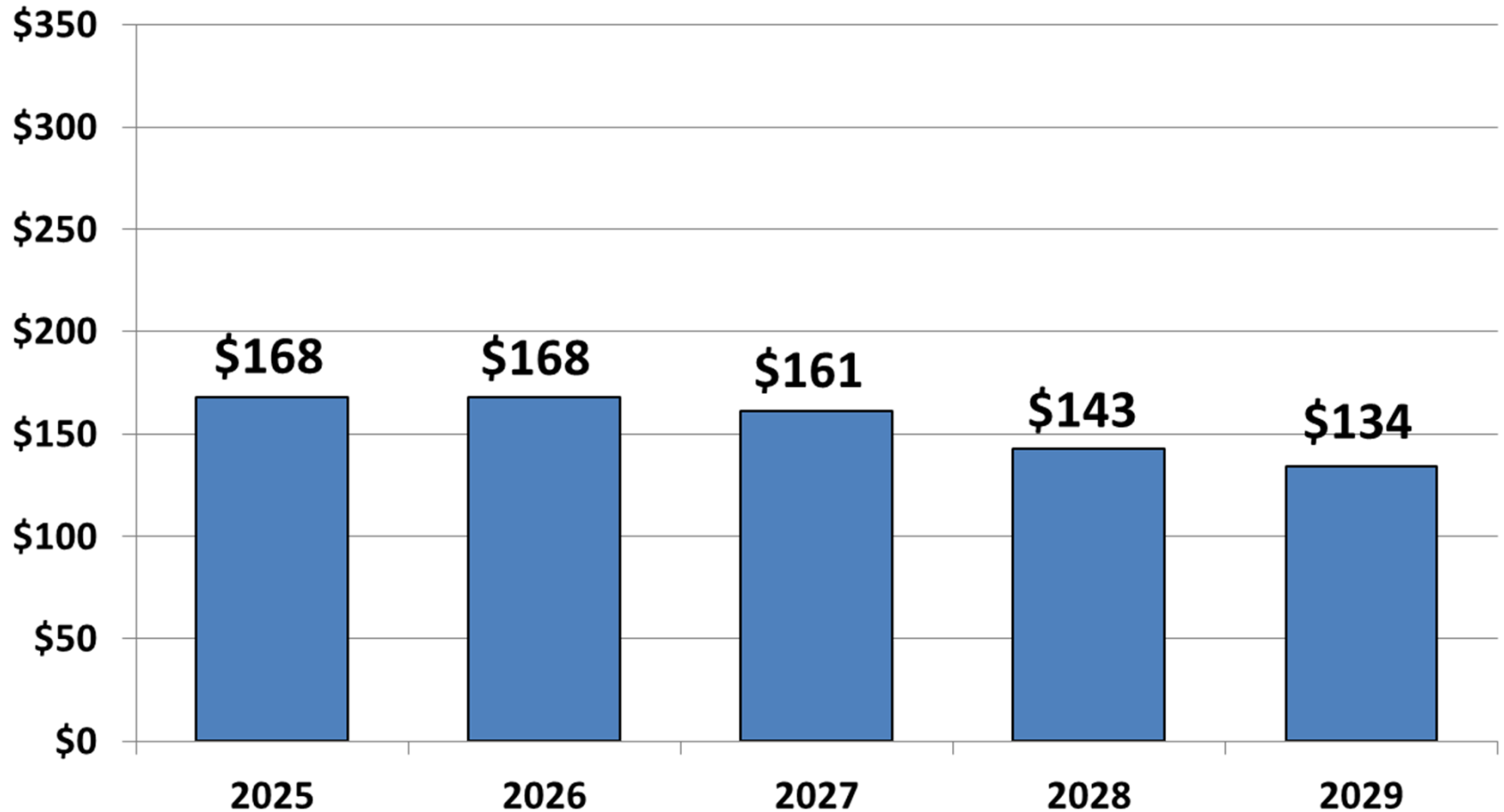
